WTRUST (WTT) is more than just a token — it's an ecosystem initiative focused on providing real value to everyday users through fair access, passive growth via staking, and utility-driven integrations with Web3 services.

3. Vision and Mission

Vision:

To build a global decentralized financial ecosystem where individuals are empowered to grow their wealth and contribute to innovation.

Mission:

Deploy a secure BEP-20 token, reward supporters, provide staking income, establish governance, and integrate real-world utility.

DeFi has surpassed \$100 billion in Total Value Locked. However, many projects lack fairness and long-term sustainability. WTRUST addresses this by enabling fair token distribution and delivering tangible utility to encourage long-term participation and growth.

- Key functions: transfer, stake, claim, burn, governance
- Upgradable using proxy pattern (planned)

- Treasury secured using multisig wallet
- Liquidity locked for 12 months
- Anti-bot mechanisms at token launch
